****IMPORTANT INSTRUCTIONS FOR APPLICANTS!****

The deferred action offer will be available to those in proceedings, those with final removal orders, as well as to those who apply affirmatively.

The Administration is not yet accepting applications for this action. Within sixty days – by the middle of August – the Administration expects to issue guidance and information about how eligible individuals can request deferred action and work authorization.

If you are not in removal proceedings, **DO NOT** apply for deferred action at this time. Unfortunately, this policy may open the door for fraud and deception by so-called “Notarios.” In the United States, notarios have no legal background and cannot act as a qualified attorney. Anyone claiming they can submit an application or charging a fee for applying for deferred action should **NOT** be trusted until the process been announced by the federal government.

Even though deferred action will help many people, applicants must be careful to ensure they are qualified when they apply. An application could still lead to deportation if an applicant is ineligible. The application will have to include solid proof that you meet all of the eligibility criteria including date of first entry, continuous residence and no convictions for certain crimes (including DUI).
